What is the interest rate?	<ul style="list-style-type: none"> The Interest Rate (gross/AER variable) is payable in IGNITE: The Account for JN members - UK residents account balances between £1 - £500,000 = 4.01% gross/AER variable. The amount of interest you will earn will apply to the whole balance in your account. AER stands for Annual Equivalent Rate and illustrates what the interest rate would be if paid and compounded once each year. Gross interest is the interest rate paid without the deduction of income tax. Interest is calculated daily and paid monthly into the IGNITE: The Account for JN Members on the last working day of the month. You can check the interest rate applicable to your account on any day by logging into internet banking. 	
Can JN Bank change the interest rate?	Rates are variable. This means we may increase or decrease interest rates at any time, for example, to reflect a change in the Bank of England bank rate, if there are changes in the cost to us of providing accounts to you, or to maintain our financial stability. We will contact you to tell you when your interest rate changes. For further information (including the reasons we may make changes to our rates) please refer to clause 8 of our Savings Account General Terms and Conditions.

	<ul style="list-style-type: none"> • You must be aged 18 or over and be a UK resident to open an IGNITE: The Account for JN Members. • You must either have a JN bank account in Jamaica or a transaction number from JN Money services. • The minimum amount you can deposit in the account is £1. • You must have a bank account in the UK. • The account must be opened in sole name only. • You can open only one IGNITE: The Account for JN members - UK residents account with us. • The maximum amount that can be deposited in the account is £500,000. • You must invest a minimum of £1 within 14 days of account opening to ensure that your account remains open. • You do not have to deposit any further minimum amount at any time following the initial deposit.
<p>Can I withdraw money?</p>	<p>You can transfer money from your IGNITE: The account for JN members - UK residents Account to:</p> <p>A) Your nominated account held in your name with a UK bank or building society which is part of the UK clearing system.</p> <p>B) Your JN bank nominated account in Jamaica. Please make sure the JN bank account in Jamaica has the ability to receive money from your account with us. Transfers from the UK to Jamaica will take up to five working days to reflect in your account. If the transaction is initiated after 5pm, the processing time will begin on the next working day.</p> <p>All nominated accounts must be in Pound Sterling (GBP). Withdrawals can be made by electronic transfer via the JN Bank internet banking service, with a daily withdrawal limit of £50,000.</p>

Additional Information

- You can fund your account in two ways:
 - The fastest and most secure method is through open banking via our authorised open banking partner, Bud Financial Ltd. This method is only available for your initial deposit when your account is open.
 - You can make a direct money transfer through your UK nominated bank account.
- Deposits can only be made through your UK nominated account.
- If you want to switch to another JN Bank product or close your account, please contact Customer Services on 0808 196 1945.
- This is not a bonus account. Interest is paid gross.
- The Personal Savings Allowance is £1,000 for basic rate taxpayers and £500 for higher rate taxpayers. Additional rate taxpayers don't receive a Personal Savings Allowance.
